The Suncoast Credit Union is awarding two (2) \$2,000 **Suncoast Credit Union Scholars** scholarships to high school seniors in Dixie County through the Dixie Education Foundation. To be eligible to apply, candidates must meet the following minimum requirements:

- must be high school seniors attending a traditional public or charter school or participating in home school or distance learning options sanctioned by the School District. **Private school students are not eligible to apply.**
- have demonstrated financial need.
- be enrolled in accredited 4-year college/university, 2-year college or technical school in **Florida.**
- begin post-secondary school in 2024-25 academic year.
- use scholarship funds for tuition, required educational institution fees, and/or other direct course-related expenses required of all students enrolled in the course of instruction, such as books, supplies and equipment.
- NOT be Directors, employees, or family members of Directors or employees of Suncoast Credit Union, Members Title Company, Members Insurance Services, Members Trust Company or Suncoast Realty Solutions LLC.

3. Attach copy of most recent family Income Tax Return (2023 or 204)
